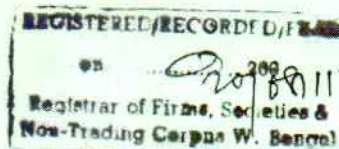

1. Name of the society shall be SONARPUR PROGATIR PATHE
2. The Registered Office of the Society shall be situated at Sonarpur, Noapara, P.O. + P.S. - Sonarpur, Kolkata - 700150, in the state of Paschim Banga (India).
3. Aims & Objects :
 - a) To provide home, education and health facility to destitute needy, less privileged and orphan children without discrimination of race, nationality, caste or creed & to arrange short stay home;
 - b) The foundation shall strive for social welfare of the members of the society and general public at large, specially from Rural Community.
 - c) To establish and maintain a Computer Education Center for the purpose of education on computer science among the interested persons by the qualified teachers.
 - d) To adopt sympathetic approaches for care and rehabilitation of men & women in difficult circumstances.
 - e) An innovative Approaches towards enhancement of facilities of Public Health for the downtrodden Especially for the rural Population.
 - f) To help the handicapped persons for their education, rehabilitation, health and all round development in Life;
 - g) To do all social welfare and rural development activities including sanitation, community health, road development and to adopt all sorts of schemes for the welfare of the children, women, persons with disabilities and poor people mainly SC/ST and other backward categories given or supported by Govt. and other national and foreign Agencies;
 - h) To organize Anti-pollution and Environment Purification Programme in West Bengal and all over in India.
 - i) To provide food, cloth, shelter (Temporary/Permanent), Medicine and other required facilities to the people who have faced natural calamities and / or the disaster.
 - j) To help the aged, sick, helpless and indigent persons and to provide home for the aged people unprotected girls and women in distress.
 - k) To promote National Integration and secularism various programmes are taken up with due earnestness and solemnity.

- l) To arrange and organize various types of Function, Festival, Cultural, and other activities by the samity.
- m) To organize physical culture indoor and outdoor games sports competitions exercise and other types of amusements.
- n) To stop the trafficking of women and children and put an end to the practice of child-marriage.
- o) To help the children of poor families for all communities and continuation of studies, and help the orphan and street children for proper health care & other activities related to their development.
- p) To acquire established, start, aid, run, maintain and / or manage Educational Institution, Residential Primary School, Library, Charitable Dispensary & Hospital, old age home, Orphan Home, Drug, Alcohol, Detoxification, Rehabilitation & Counselling Residential Centre and the like without Profit motive.
- q) To help the woman in crisis situation for their better livelihood.
- r) To generate awareness and take initiatives on reproductive Child Health, Mother and Child Care, AIDS, General Health and Hygiene, Public Health among the poor people of all communities.
- s) To promote and encourage advancement of literacy, cultural, scientific and Technical education.
- t) To arrange for Seminar/workshop of Horticulture, Pisciculture, Animal husbandry etc. for the sake of all round agricultural development and training.
- u) To arrange and organize vocational training.
- v) To arrange and organize lectures, debates, discussions, seminars workshops, exhibitions excursions of diffusion of knowledge and creating public opinion on health, education, human rights and environment issues.
- w) To help to organise Self-Help Group based programme for augmentation of the livelihood opportunities of the people at the grass root level as considered beneficial to the public in general.
- x) To social welfare activities including public health and other development works of the locality.
- y) To arrange and organize various types of Function, Festival, Cultural, Games and Sports and other activities by the samity.
